

On Thursday 24" June, we will be celebrating RSE day!

RSE Day began in Nottingham in 2018 as a celebration of positive Relationships and Sex Education happening in the City. The day provides an opportunity for schools, communities and families to explore and discuss healthy relationships, growing up, wellbeing, respect and resilience.

The theme for this year's RSE day is 'Faces'. Each class will be helping to identify positive role models in our school community: who has shown good friendship skills? Who makes sure no one is left out? Who is kind and polite? A positive role model from each class will be awarded a 'Face of Healthy Relationships' certificate.

Here are some other activities which will be taking place in school:

<u>Phase</u>	Classroom Activities		
Foundation (Nursery and Reception)	<u>Emotions</u> Children will be exploring how we show emotion in our faces. They will be getting creative and thinking how they can show different emotions people experience.		
Key Stage 1 (Year 1 and 2)	What Makes A Good Friend? Children will be sharing different stories which explore friendship and creating a piece of artwork with the title, 'A Friendly Face'.		
Lower Key Stage 2 (Year 3 and 4)	Positive Faces Children will be using heart-shaped cut outs to create a self-portrait and write something positive about themselves. They will be discussing their strengths and things they love.		
Upper Key Stage 2 (Year 5 and 6)	Different Hearts Children will be asked to create hearts using different media; they will be using paint, chalk, twigs, paper, recycling, leaves, and anything else they can think of. They will be discussing what love is and why it's important in relationships.

You can bring your entry into school or email a photo to your class email address. Entries into the competition will be showcased around school and the winner will have their entry framed with a certificate. **EU settlement Scheme – Information from the Government Home Office:** With the EU Settlement Scheme (EUSS) application deadline (30th June) fast approaching, the Home Office would like to remind parents, families, young people and staff that if you are an EU, EEA or Swiss citizen, you and your family members may be eligible to apply to the Settlement Scheme.

It is crucial that eligible parents apply to the Scheme yourselves and check whether you need to do so on behalf of your children. Eligible children are required to have an application in their own right and no child of any age is covered by a parent's application to the EUSS. There's more information on this here on GOV.UK.

To provide additional guidance, a very clear EUSS <u>leaflet</u> has been produced by the University of Liverpool, in partnership with the Home Office. It has been designed with children in mind and is intended to support both children and parents with information to help them apply to the EUSS. A set of accompanying <u>FAQs</u> are available too. A list of organisations providing additional EUSS guidance and information is available <u>here</u>.

Applications to the EUSS are free and can be made online at <u>www.gov.uk/eusettlementscheme</u>, where you can also find out more information about how to apply. This is not something which can be done through school.

COVID-19 INFORMATION:

There remains a risk of Covid 19 closing bubbles in school. We continue to follow strict risk assessments and ask that you please take note of the following points which will help to protect the children and staff.

IMPORTANT! Please let school know if anyone in your household is self-isolating or has had a positive Covid test result using <u>covidreporting@heathfield.nottingham.sch.uk</u> so we can track and trace any close contacts or close a bubble as necessary.

The Prime Minister announced an extension to restrictions until at least 19th July. We will still be in bubbles until the end of term and it has not yet been advised if this will be the case in September. We hope not but know that we have good systems to minimise risk in school.

We need parents to ensure that if you or your child have any symptoms that a PCR test is done to enable school to make the appropriate decisions on class closures.

ALL absence should be reported to school. You can leave a message on the answer phone, call the office during school hours, or email the school at <u>admin@heathfield.nottingham.sch.uk</u> or use the covid email address above.

If you are travelling outside of the UK over the school holidays, please consider the implication of any <u>quarantine affecting your ability to comply with statutory school attendance</u>. Please inform the school office if you are leaving the UK so we are able to advise on leave of absence forms and implication for return dates.
